School Rules - Our Code of Conduct

1 Introduction

In alignment with the Junyuan Story, to develop our students to become better persons for others, the development and practice of good habits and self-discipline are essential for their holistic development.

The following rules and regulations represent our Code of Conduct to support the students in understanding the importance of good moral behaviour, respect for self and others and to create a safe and conducive environment for learning. The expectations of behaviour are aligned to the school values of Respect, Resilience, Responsibility and Excellence.

2 School Attendance

2.1 Application for taking attendance: School Cockpit Mobile (SC Mobile)

Student attendance will be taken at the Assembly Venue (Parade Square / Hall / Classroom) on a school day, after the National Anthem and Pledge-Taking. The student's attendance is reflected as ONE of the following:

- Present
- Absent with Valid Reason (MC)
- Absent with Valid Reason (Private)
- Absent with Valid Reason (Official)
- Absent Pending Reason
- Absent Without Reason
- Late
- **2.2 Follow-up**: When a student is not physically at the Assembly Venue (Parade Square / Hall / Classroom), he/she will be marked as "Absent Pending Reason" as the default update. Form Teachers will update the attendance accordingly once information has been received through (but not limited to) phone calls, hardcopy notices or other forms of communication from parent/guardian (e.g. email, submission via Parents Gateway). If no information is received after 5 school days, the student's attendance will be updated as "Absent Without Reason".
- **2.3** Attendance Updates for parents / guardians: When a child is marked "Absent" or "Late", the system will automatically send an SMS to the parent or guardian between 9:00 a.m. to 9.30 a.m. informing them of the student's absence from school or late-coming.

2.4 Attendance Monitoring

Attendance is a critical factor for learning, development and well-being. Students must attend and be punctual for all school activities. Students who attend school less than 90% of the time are at severe risk of underachievement. As such, students whose attendance drops below 90% will be monitored more closely. This is to support students to manage their time effectively, develop self-discipline and take ownership of their learning.

- 2.5 Absence from school must be supported by a medical certificate. Excuse from school may be granted on compassionate grounds or on a case-by-case basis. Parents' letters to cover absence due to other valid reasons should be submitted to the Form Teacher upon returning to school and should not exceed 2 days per term.
- 2.6 For urgent private matters, permission to leave school early may be granted for special cases. The Form Teacher must be informed by the student using the blue "Permission to leave school early" slip which can be obtained from the General Office.
- 2.7 Students must attend all school programmes (including lessons, CCAs, assemblies) punctually. Students who are exempted from, have officially dropped a subject, or are taking a subject not offered in Junyuan (e.g., Mother Tongue Languages) must remain in the classroom during those lesson periods, unless they have been specifically instructed to report to the school library. In all cases, students must not leave the classroom or designated venue without permission from the teacher.
- 2.8 All students must stand at attention for the flag-raising ceremony.
- 2.9 Students who are Singapore citizens must sing the National Anthem and take the Pledge. Students will take the Pledge with the right fist over the heart.

2.10 For all other assemblies (hall/level/cohort/school) programmes etc, students must conduct themselves appropriately and behave responsibly and respectfully. Students should adhere to the timing for assemblies and be punctual.

3 Punctuality & Late Coming

3.1 Punctuality

Morning assemblies will start promptly at 7.50 a.m. (Mon, Tue and Thu) and 8.30 a.m. (Wed and Fri) at the Parade Square / Hall / Classroom for flag-raising.

- 3.2 Students who are not at the assembly venue by 7.50 a.m. (Mon, Tue and Thu) and by 8.30 a.m. (Wed and Fri), will report to teachers on duty and will be marked as "Late". Late-comers who report to school after the morning assembly are to report to the General Office for attendance taking.
- 3.3 All latecomers are expected to "put things right" on days that they report late, e.g. **participate in corrective work, etc**.

- Affects eligibility for MOE and School Awards, e.g. Edusave Character Award, EAGLES Award, etc.

- Affects eligibility for leadership opportunities.

4 General Behaviour

4.1 Responsible Use of Mobile Devices (not limited to mobile phones)

- 4.1.1 With the exception of their Personal Learning Device (PLD), students are discouraged from bringing their mobile devices (such as mobile phones, smart watches, blue-tooth ear-pods, Airpods, game consoles, etc) to school. Students bring their mobile devices to school at their own risk and should exercise care over their own valuables at all times. The school will not be held liable or responsible for any loss.
- 4.1.2 During curriculum time, students are allowed to use their PLDs for purposes of learning and with permission from the teacher. Students should follow their teachers' instructions on the use of the devices.
- 4.1.3 To maintain a conducive and respectful learning environment, and enable students to focus on learning, students should not access their mobile devices (MDs) from 7.50 a.m. (Mon, Tue and Thu) and 8.30 a.m. (Wed and Fri) till the end of the school day (including recess, breaks and CCA).

- 4.1.4 All mobile devices should be turned off (not just put on silent mode) and locked away in their personal lockers before morning assembly. Students who breach these regulations will be managed in accordance to the consequences listed in the table below.
- 4.1.5 At the end of the school day, students will retrieve their mobile devices from the lockers. Students must ensure their mobile phones are kept on silent mode as long as they are in school.
- 4.1.6 In the case of an emergency, parents/guardians can call the school General Office at 6587 3683 to contact the student. Students may use the telephone in the General Office if they need to contact parents/guardians.
- 4.1.7 Usage of mobile devices during official school activities such as learning journeys and school camps will similarly be subjected to the needs of the activities and teachers' approval to ensure that students focus on the learning activities.

4.2 Acceptable Usage of Personal Learning Device & School ICT Resources

- 4.2.1 Students are reminded to observe the guidelines stated below on the use of personal learning devices (PLDs) and the school's ICT resources. ICT resources include the following, but are not limited to, MOE/school-deployed ICT system accounts, the device management application (DMA) and school's internet network.
- 4.2.2 Students are responsible for their PLDs. In the event of loss or theft of the device, students must make a police report and report the matter to the school.
- 4.2.3 All PLDs are installed with a device management application (DMA) to support a safe and conducive learning environment. Students should not attempt to uninstall the DMA or de-enroll the PLD from the DMA. Disciplinary actions will be taken for any such attempts.
- 4.2.4 Students should not attempt to access data, system and information that they are not authorised to.
- 4.2.5 Students are reminded that the use of PLDs and school's ICT resources should solely be for the purpose of learning.
- 4.2.6 Students should not use MOE/school-deployed ICT system accounts for any commercial activities (*e.g.* buying and selling of goods and services).
- 4.2.7 Students should not use, copy or share digital files in an unauthorised or illegal manner.

4.3 Behaviour in School Premises

- 4.3.1 To ensure safety and respect for others in the school, students should move in an orderly manner.
- 4.3.2 Students must dismount from their bicycles in the school compound, walk and park them at the designated parking areas. All bicycles must be fitted with at least one functioning handbrake before they are allowed for use. Bicycles without at least one functioning handbrake may be clamped for safety reasons and parents/guardians would be requested to collect them.



4.3.3 All bicycle users are required to complete the online registration form (Bicycle Registration form).

- 4.3.4 All food and drinks should be consumed in the School Canteeen or the designated areas at the ground level. Beyond these areas, only bottled plain water is allowed. Exceptions will be made for sports CCA training when teachers' permission is given for isotonic drinks to be consumed at the respective training venues. Students are not allowed to consume food and drinks in their classrooms or other learning spaces, including sports facilities such as the school field and basketball court.
- 4.3.5 Students should keep the school premises free of litter.
- 4.3.6 Students are expected to take good care of their personal belongings.

4.4 Behaviour at the Assembly Area

- 4.4.1 Assemble according to classes and index numbers quickly and quietly.
- 4.4.2 Show appreciation and behave with consideration towards the speaker or the event/performance.

4.5 Behaviour in the Classroom or Learning Venues

- 4.5.1 Students must keep their classrooms/learning venues clean and tidy at all times.
- 4.5.2 Students should be ready for their lessons immediately when the bell rings for lessons. For venues that are further away, students have up to 5 minutes to reach their venue. Students must have all their materials for the lessons. Homework and assignments are to be duly completed.
- 4.5.3 Students should lock up their valuables (including wallets) in their lockers at the start of the day and not bring their valuables around for lessons.
- 4.5.4 Students must switch off electrical items such as lights and fans before leaving the class.
- 4.5.5 Students should not leave books and files in the classroom after dismissal unless given permission by their subject teachers. All books and files are to be stored neatly in the assigned class cabinets.

4.6 Behaviour in Public Spaces

- 4.6.1 Students must uphold the good name of the school by ensuring that they are at their best behavior in public, whether in the school uniform or otherwise.
- 4.6.2 Students are to be considerate, gracious, respectful and responsible in public areas. They are to observe and abide by the rules and regulations within the areas that they are patronizing and/or visiting.

4.6.3 Students who are found violating these rules and regulations may face consequence meted out by the school in addition to any fines or punishments imposed by the authorities.

4.7 Behaviour Towards Others

A safe and secure community requires all members to be respectful to each other. Hence, the school does not tolerate any action (whether verbal, non-verbal) that undermines a person's rights. In relation to this, the school will take whatever steps necessary to prevent, or intervene in, to prevent any form of bullying behaviour. Every member of the school community has the right to be free from bullying. All staff and students of the school community have a responsibility to actively practice and promote:

- Tolerance for individual differences
- The values of respect, responsibility and care for others in the conduct of relationships
- A supportive and encouraging climate where the achievements and efforts of others are applauded
- A commitment to adhering to, and upholding, all aspects of this policy

Students should inform a teacher or staff should they experience or witness any form of bullying.

4.8 Photography & Use of Social Media

- 4.8.1 Students must practice responsibility and respect in the use of social media. Flaming, defamatory comments, sharing and uploading of offensive materials on the Internet including websites, blogs, social media, messaging platforms, and emails, can constitute an offence.
- 4.8.2 Students should practice caution with the use of language on any website, direct messaging, blogs and social networking sites.
- 4.8.3 Areas in the school may be subjected to images captured as part of the daily functioning of the school, using film photography, digital photography, video or any other medium. As such, photographs or video images of the students may be taken during school activities and events such as classroom lessons, CCA, school camps, or school concerts.
- 4.8.4 The school may use photographs or video recordings taken at school events for school publications, the school's website, social media channels, or other official communication channels. These may also be provided to the media for publication in local or national newspapers or educational magazines.

5.1.1 Students are to wear the prescribed school uniform and modification to the uniform is not allowed.

- 5.1.2 Sleeves should not be folded.
- 5.1.3 Students can choose to wear white school shoes or sports shoes* on school days. Only plain coloured socks are allowed.
 - *Sports shoes do not include sneakers, canvas shoes or any other form of shoes not meant for sports activities.
- 5.1.4 The school tie is worn during designated school events. Students will be informed of such events.
- 5.1.5 If a student cannot wear shoes due to medical reasons, the Form Teacher must be informed with the support of a doctor or parent's letter.
- 5.1.6 During the school holidays, students who return to school for any school activities must be properly attired. No slippers are allowed. Students who are not properly attired (e.g. improper attire, hairstyle or hair colour) will not be allowed entry into the school compound.
- 5.1.7 All students' attire are to conform to the school's expectations. Should the attire be observed to be inappropriate (e.g. tapered pants, skirt of inappropriate length etc), the student would be advised to ask

for a change of attire at the General Office before he/she is allowed to attend lessons. The school will also work with the parents/guardians to remind the child/ward on appropriate conduct.

Boys Girls

Uniform

- School shirts and pants or shorts must be purchased from the authorised supplier.
- The school pants may be altered if necessary (typically the length or waist size).
- Long pants that are modified e.g. "skinny pants or tapered pants" cannot be used as part of the student uniform/attire.

The school reserves the right to request for the student to change into an appropriate pair of pants if it is deemed to have been altered excessively.

Uniform

- School shirts and skirts must be purchased from the authorised supplier.
- The school skirt may be altered if necessary (typically the length* or waist size).

*Skirts should be at knee-length, i.e. touching the knee caps. Folding at the waist is strictly not allowed. The school reserves the right to request for the student to change into an appropriate pair of pants if it is deemed to have been altered excessively.

Personal Grooming

- Male students must be neat in appearance, cleanshaven and no facial hair is allowed.
- Hair must be short and neat at all times.
- Hair must not touch the collar and must be smooth-sloped at the sides and rear. No sideburns and ducktails are allowed. The fringe must be above the eyebrows and should not be spiky.
- Hairstyles such as side-shaven, undercut, long fringes etc are not allowed. It is advisable for a student to check with the Form Teacher/ Year Head/ Student Management Committee the intended hairstyle before getting a new hairstyle.
- Fancy hair styling, tinting, dyeing, highlighting and bleaching of hair are strictly not allowed for all students#

Personal Grooming

- Female students must be neat in appearance.
- Short hair should be neat and kept above the shoulder.
- Long hair must be neatly tied up with simple black or dark blue ribbons, hair bands and/or hair clips.
- Fringes must be neat and above the eyebrows or pinned with black clips or black hair band at all times behind the ears.
- Hairstyles such as side-shaven, undercut etc are not allowed.
- Fancy hair styling, tinting, dyeing, highlighting and bleaching of hair are strictly not allowed for all students#

General

- Tattoos are strictly not allowed on any part of the body. Students found with tattoos will be suspended until they are removed.
- No jewellery and accessories (rings, bracelets, necklaces) or make-up are to be worn.
- Body piercings are strictly prohibited and must be removed.
- Ear studs/rings are not allowed.
- Nails must be kept short and clean. Nail polish, varnish or hardener is not allowed. Students whose nail grooming is not appropriate will be asked to correct them immediately.

The school reserves the right to confiscate any items that are prohibited.

General

- Tattoos are strictly not allowed on any part of the body. Students found with tattoos will be suspended until they are removed.
- No jewellery and accessories (rings, bracelets, necklaces) or make-up are to be worn.
- Body piercings are strictly prohibited and must be removed.
- Only one identical pair or ear-studs are allowed to be worn. Ear rings, 'ear sticks', multiple earrings/studs are not allowed for safety reasons.
- Nails must be kept short and clean. Nail polish, varnish or hardener is not allowed. Students whose nail grooming is not appropriate will be asked to correct them immediately.

The school reserves the right to confiscate any items that are prohibited.

[#] Students with inappropriate hairstyle and/or hair colour will be given specific instructions to trim and/or re-dye the hair. Should the second warning be ignored, the school reserves the right to bring the student for a haircut and the cost will be borne by the student. The parent/guardian will be informed and the student may face home suspension and other consequences until the issue is rectified.

6 Acts of Misconduct & Consequences (Restorative Practices)

In line with the school vision of developing Champions for the Community, where students become persons of good character and contribute to the community, the school adopts Restorative Practices as a whole-school approach in the area of student management.

Students will be asked to reflect on the misconduct made and learn from that experience.

The school believes in involving both the student and his/her parent/guardian in working out the appropriate intervention to allow the student to take responsibility for his/her actions.

^{*}The school reserves the right to mete out appropriate consequences and to involve external agencies whenever deemed necessary, if a student behaves in any other way detrimental to the moral tone of the school.

A minor act of misconduct committed three times and above may be considered as a serious act of misconduct and warrant more severe consequences. Student leaders, including Student Councillors, CCA Leaders and Class Committee Members who commit a serious act of misconduct may be dismissed from their leadership roles.

The school reserves the right to mete out the above or any other appropriate actions against the student(s) besides the consequences stated above, depending on the frequency / severity of the offence committed. The school reserves the right to deal with student discipline on a case-by-case basis. The school may check the students' mobile phones and cyber activities when it is necessary to establish a misdemeanor or a breach of the school rules has been committed.

6.3 Possession of Weapons/Banned Items

- Students are not allowed to bring any banned items and/or other items with the potential of causing hurt or injury to school.
- All students are not allowed to have in possession of any weapon. They are also not allowed to bring any weapon-like item which can be used or intended to be used to cause harm to others.
- List of banned items (the list is not exhaustive)
 - Cigarettes
 - o Lighters
 - Playing cards
 - Pornographic materials
 - o Portable electronic devices for gaming and entertainment purposes
 - Vaporisers
 - Vanity set (make-up paraphernalia)
 - o Weapons
 - o any other item(s) deemed inappropriate or offensive

The school reserves the right to confiscate any weapons/banned items found in possession.

6.4 Smoking, Vaping & Tobacco-related Offences

- Students are not allowed to smoke in the school's premises or possess any cigarettes or lighters.
- As of 1 January 2021, the minimum age for smoking in Singapore is 21 years old
 - *Under the amended Smoking Act, section 11 (1) of the Tobacco (Control of Advertisements and Sale) Act (Chapter 309), a person who, being an under-aged person, (a) uses or has in the person's possession, in a public place or on a road in Singapore, any tobacco product; or (b) buys in Singapore any tobacco product, shall be guilty of an offence and shall be liable on conviction to a fine not exceeding \$300. Cases involving contraband cigarettes will be referred to Customs and/or Police
- Under section 16(1) of the Tobacco (Control of Advertisements and Sale) Act (TCASA), it is illegal
 to import in Singapore, or distribute, sell, offer for sale or possess for sale in Singapore, any
 imitation tobacco products (e.g. vaporisers) in Singapore as of 1 February 2018. This includes
 e-cigarettes, e-pipes and e-cigars as the TCASA covers any toy, device or article:
 - that resembles, or is designed to resemble, a tobacco product;
 - that is capable of being smoked;
 - that may be used in such a way as to mimic the act of smoking; or

- the packaging of which resembles, or is designed to resemble, the packaging commonly associated with tobacco products.
- Persons found guilty of this offence can be fined up to \$20,000.
- In addition, under section 16(2) of the TCASA, it has been **illegal to import vaporisers** from 1 August 2016 onwards. This means that **buying vaporisers online and shipping them to Singapore for personal use is illegal**. Those guilty of the offence are liable to a fine of up to \$10,000 and/or up to 6 months' jail. Repeat offenders are liable to a fine of up to \$20,000 and/or up to 12 months' jail.
- MOE and schools take a "zero tolerance" stance on vaping. The following school-based disciplinary actions will be meted out in addition to the national penalties imposed by HSA.

- Students caught selling and trafficking of e-vaporisers may be considered for additional school-based consequences, including expulsion.
- Students caught vaping will have their privileges removed, including suspension of leadership roles, and non-eligibility for representation of school at NSG / SYF / competitions, overseas trips, character awards and scholarships for the rest of the year.
- Students with a history of vaping offences will have their bags/lockers spot checked.

6.5 Breach of Examination Rules and Regulations

- 6.5.1 Students are to adhere strictly to all examination rules and regulations, during WAs and End of Year examinations:
 - Students must not communicate or attempt to communicate with other candidate(s) / unauthorised person(s) during the examination, or during any other occasions when communication is prohibited, e.g. example, when the answer scripts are being collected, or during movement to the guarantined area.
 - Students should always face the front and not attempt to look around during the examination to avoid any misunderstanding that they were attempting to commit a dishonest act.
 - Students must not exhibit improper conduct or misbehaviour during the examination, e.g. disturb other candidates, or disobey instructions from examination personnel.
 - Students must not attempt to benefit from another candidate's work, nor offer any advantage to another candidate during the examination. This includes but is not limited to: copying from another candidate's answer script, allowing another candidate to copy from one's own work, or sharing examination materials or information.
- 6.5.2 Non-compliance with the regulations in 6.5.1 constitutes a breach of examination rules. Students found in breach may face penalties, including receiving zero marks for the paper.
- 6.5.3 Only approved calculators and dictionaries are allowed into the examination venue for examinations which allow the use of calculators and dictionaries. Students found in possession of a calculator with unacceptable features and/or attempt to retrieve information / programmes from the calculator during the examinations would also be considered to have breached the examination rules and regulations.. The calculator may also be confiscated for the duration of the examinations.

7 Assessment Matters

- 7.1.1 For Sec 1, 2 and 3 students in 2026.



8.3 Polytechnic Foundation Programme (PFP) for 2026 Sec 4 Normal Academic Graduates (information taken from https://pfp.polytechnic.edu.sg)

- 8.3.1 The Polytechnic Foundation Programme (PFP) is a one-year programme that offers a practice-oriented curriculum taught by polytechnic lecturers, to better prepare polytechnic-bound N(A) students for entry into the relevant Polytechnic Diploma courses. This is an alternative to the Sec 5 year. PFP students are given provisional places in diploma programmes, subject to them passing all modules in the one-year PFP. The requirement to pass all modules ensures that students continue to work hard during their PFP year and are well prepared for polytechnic studies. Students who apply effort should have no difficulties in meeting the requirement.
- 8.3.2 The PFP caters to students of the Sec 4N(A) cohort in the preceding year. The PFP will have about 1,500 places set aside each year. It will be offered by all five Polytechnics. More than 80% of Polytechnic Diploma courses will be offered under the PFP.
- 8.3.3 To be eligible to apply for the PFP, N(A) students must obtain ELMAB3 (English, Mathematics, Best 3 Subjects) raw aggregate score of 12 points or better (excluding CCA bonus points) at the GCE 'N'-Level examination; and meet the following subject-specific requirements:

8.4 Direct-Entry-Scheme to Polytechnic Programme (DPP) for 2026 Sec 4 Normal Academic Graduates

- 8.4.1 The Direct-Entry-Scheme to Polytechnic Programme (DPP) is one of the two Normal (Academic) through-train pathways that were launched in 2013. It allows Secondary 4 N(A) students to be admitted directly into a 2-year Higher Nitec programme at the Institute of Technical Education (ITE) without having to sit for the O-Level examinations or undergo a Nitec programme.
- 8.4.2 To be eligible to apply for the DPP, N(A) students must obtain:
 - i. ELMAB3 (English, Mathematics, Best 3 Subjects) raw aggregate score of 19 points or better (excluding CCA bonus points) at the GCE 'N'-Level examination; and
 - ii. the following subject-specific requirements:

For applied sciences, engineering or info-communications technology courses

- English Language (Syllabus A): A grade of 1 to 4.
- Mathematics (Syllabus A or Additional): A grade of 1 to 4.
- 3 other best subjects, excluding CCA: A grade of 1 to 5 for each subject.

For business & services or hospitality courses

- English Language (Syllabus A): A grade of 1 to 3.
- Mathematics (Syllabus A or Additional): A grade of 1 to 4.
- 3 other best subjects, excluding CCA: A grade of 1 to 5 for each subject.


